Dear Ms. Friis:

The North American Electric Reliability Corporation ("NERC") hereby provides notice of proposed amendments to the Compliance and Certification Committee ("CCC") Charter. This filing consists of this transmittal letter; Attachment 1, which contains a clean version of the proposed amendments to the CCC Charter; and Attachment 2, which contains a redline version of the proposed amendments to the CCC Charter.

**Proposed Amendments**

The proposed amendments to the CCC Charter were made to update references to the NERC CCC membership structure to reflect organizational changes within the ERO Enterprise. Specifically, the proposed amendments reflect the dissolution of the Southwest Power Pool Regional Entity ("SPP RE") by removing SPP RE from the Regional Entity sector in the CCC membership structure found in Attachment A of the CCC Charter.

NERC submitted notices of revisions to the CCC Charter on April 5, 2010 and March 22, 2018. On November 7, 2018, the NERC Board of Trustees approved the revised CCC Charter contained herein.<sup>2</sup>
