Ladies and Gentlemen:

**Implementing Version 3 of the
Operating Reliability Data Confidentiality Agreement**

At its May 6, 2009 meeting, the NERC Board of Trustees approved ORD Agreement Version 3 to take the place of the August 2005 Agreement. ORD Agreement Version 3 replaces the Confidentiality Agreement for Electric System Security Data approved August 2, 2005 (the August 2005 Agreement), that you signed previously. This letter is to request that you sign the attached Version 3 of the NERC Confidentiality Agreement for Operating Reliability Data (ORD Agreement Version 3), as soon as possible, but no later than **September 1, 2009**, to:

Background

The purpose of the amendments to the August 2005 Agreement is to facilitate implementation of a project that the Reliability Coordinators, NERC, the Regional Entities and FERC staff have developed to provide improved understanding and communication about the status of the bulk power system among those entities. This situational awareness and visualization project (Situational Awareness for FERC, NERC, and the Regional Entities, or SAFNR) will make use of a subset of operating reliability data and create a common set of displays about the near-real time status of the bulk power system for FERC staff, NERC, the Regional Entities, and the Reliability Coordinators. The project will begin June 1, 2009.

As directed by the Board of Trustees, NERC signed ORD Agreement Version 3 on May 8, 2009, and it will become effective for each signatory on the date the entity signs. The August 2005 Agreement and the ORD Agreement Version 3 will both be in effect for a period of 120 days to provide time for NERC to complete the process of getting signatures on ORD Agreement Version 3. NERC will no longer sign the August 2005 Agreement.

ORD Agreement Version 3 continues the disclaimers and hold-harmless provisions that are contained in the August 2005 Agreement. ORD Agreement Version 3 also expressly states that it does not restrict the ability of a party to disclose its own operating reliability data to others under separate agreements. The Board of Trustees removed the eight-day exception contained in the August 2005 Agreement, because ORD Agreement Version 3 covers critical energy infrastructure information, and that information does not lose that status after the passage of eight days. ORD Agreement Version 3 expressly includes phasor measurement data within the definition of operating reliability data, as did the August 2005 Agreement.

The Board of Trustees also approved conforming changes to Annex 1 and Annex 2 to ORD Agreement Version 3. It will be necessary for entities that have signed Annex 1 or Annex 2 to sign the new versions of those documents.

I have attached instructions for submitting the ORD Agreement Version 3 to NERC.

4. For each Nuclear Generating Plant desiring access to data, the Small Bundled Entity and the relevant Disclosing Party should sign Annex 2. Note that the provisions of ORD Agreement Version 3 are incorporated into Annex 2 except as expressly stated otherwise.
