

Standards Committee Nomination Form 2019-2020 Term Election – Segments 1-10 (Two-year term)

The North American Electric Reliability Corporation (NERC) [Standards Committee](#) (SC) has two members from each of the ten industry segments. Each SC member is elected by the segment he or she represents. The SC reports to the NERC Board of Trustees and oversees the development of NERC Reliability Standards by performing tasks governed by the [Standard Processes Manual](#), the [Standards Committee Charter](#), and the [SC Work Plan](#).

Anyone may submit a nomination. To be eligible for nomination, a nominee shall be an employee or agent of an entity registered in the applicable Segment. To allow verification of affiliation, **a nominee must be a registered user in the NERC Registered Ballot Body**. It is not required that the nominee be the same person as the entity’s Registered Ballot Body representative for that Segment. Instructions are provided in [Appendix 3B](#) of the NERC Rules of Procedure – *Procedure for Election of Members of the NERC Standards Committee Procedure*. Completed nomination forms will be posted on the [SC Nominations and Elections webpage](#).

Nominations are currently being accepted for each of the ten segments for a two-year term.

Mr. Buchholz is a 1988 graduate of South Dakota State University. Since his completion of a Bachelors of Science Degree in Electrical Engineering, Mr. Buchholz has been employed with the U.S. Department of Energy, Western Area Power Administration (WAPA) serving in various operations and maintenance positions at WAPA’s Headquarter’s Office in Lakewood, CO; the WAPA-UGPR, South Dakota Maintenance Office; the WAPA-UGPR Maintenance Engineering Office; and the WAPA-UGPR Watertown Operations Office.

Since May 2010, Mr. Buchholz has served as the NERC Compliance Manager for WAPA’s Upper Great Plains Region. Mr. Buchholz is a member of the Mid-Continent Compliance Forum (MCCF) Steering Committee; the Midwest Reliability Organization (MRO) Compliance Committee; the MRO Standards Committee; the MRO Performance Risk Oversight Subcommittee; and the Southwest Power Pool (SPP) Reliability Compliance Workgroup.

Mr. Buchholz's duties as the WAPA-UGPR Compliance Manager includes providing technical expertise to WAPA managers and employees on NERC Reliability Standard compliance issues. Mr. Buchholz serves as WAPA UGPR's technical expert on the NERC Reliability Standards and provides guidance on the interpretation of Reliability Standards and their application that allows the organization to meet the requirements of the Standard prior to enforcement. Mr. Buchholz's duties also include the review of proposed new or revised Reliability Standards and Interpretations to determine potential impacts to the organization and to provide an opportunity for WAPA UGPR provide comment to NERC.

Mr. Buchholz's participation on the MRO Standards Committee has provided an opportunity to participate and gain experience in acting as a resource for MRO stakeholders to learn more about the application and development of NERC Reliability Standards through communication, education, and training.

Mr. Buchholz's experience and responsibilities within WAPA and his participation on various committees and workgroups within the MRO and SPP footprints aligns well with the purpose and function of the NERC Standards Committee and if appointed, will provide a useful perspective on the future development and maintenance of the NERC Reliability Standards.
