2. Review white paper comments and develop responses

- a. Participants reviewed each comment submitted during the May-June 2016 posting of project white papers.
- b. Qun Qiu asked if Figure 5 in the Screening Criterion for Transformer Thermal Impact Assessment white paper (Screening Criterion white paper) correctly plots the information from its referenced source, the 2002 IEEE Transactions paper on results of Finnish Grid transformer testing. The SDT reviewed the reference and confirmed that the plot in the Screening Criterion white paper is correct. Ralph Painter suggested relabeling the y-axis of Figure 5 in the Screening Criterion white paper. The SDT did not believe the change added clarity.
- c. The SDT agreed to add a footnote to the *Transformer Thermal Impact Assessment* white paper referencing IEEE Std C57.163-2015, as recommended by a commenter. The SDT determined that no other revisions to project white papers were needed.
- d. The SDT agreed on responses to all commenters.



3. Discuss next steps

a. Mark Olson said that the Consideration of Comments and white papers would be posted on the project page next week. NERC is preparing a supplemental filing to enter the revised white papers in the FERC docket for proposed TPL-007-1.
