Comments on Draft SAR

Chairman Rocha led discussion on the current draft of the SAR. Margaret Stambach transcribed the comments of the drafting team and will incorporate them into a revised draft of the SAR (Version 2) that will be transmitted electronically to the drafting team. She will also draft and circulate the associated comment form, containing questions for the industry.

The drafting team also addressed responses to the industry comments received from the initial 2002 posting of this SAR (Version 1). Margaret will incorporate responses and transmit this Consideration of Comments document to the drafting team for review. The drafting team response will stress that, because the initial industry comments are somewhat outdated, the drafting team is responding to general groupings of comments instead of to each individual comment.

In addition to comments on the draft SAR-V2 and related documents, the drafting team identified several issues that it felt needed further clarification. Chairman Rocha will communicate these issues to the appropriate resource at NERC:

- 1. Clarification of definitions, particularly "cascading outages."
- 2. Use of voltage levels to further define "transmission."
- 3. Exclusion of generation resource adequacy from the Assess Transmission Plans SAR.
- 4. Confirm that the near-term (less than one year) planning horizon has been, or will be, addressed by a current standard or SAR.

Future Meetings

Incorporation of the comments of the drafting team into the SAR will be accomplished electronically, if possible, and if necessary, resolved through conference calls. The next face-to-face meeting of the drafting team will be established after receipt of comments from the posting of the SAR, Version 2 (posted for industry comment, May 5 to June 5, 2004).
