The Standards Committee (SC) nomination period to fill the following vacancies closed February 13, 2020:

• Segment 4 – 2020–2021 term

The following individuals were nominated to represent their Industry Segments:

- Ajinkya Rohankar– Segment 9

There will be vacant positions for Segment 7 (2020–2021 term) and Segment 9 (remainder of the 2019–2020 term), since no nominations were received to fill these terms.

An election will begin on Monday, February 24, 2020, and will remain open for ten calendar days closing on Wednesday, March 4, 2020 at 8:00 p.m. Eastern. Each individual or entity that is a **member of Segment 4 and 9**, may vote for a SC member to represent that Industry Segment. Proxies are allowed. Detailed information on each candidate is posted on the <u>Standards Committee's Nominations and Elections web</u> <u>page</u>. Although Ajinkya Rohankar is running unopposed, he must receive at least one vote to be elected to the SC.

Please access the appropriate voting link below based on your segment representation. You may only vote for the segment you or your entity represents.

In accordance with the <u>Procedures for Election of Members of the Standards Committee</u> contained in Appendix 3B of the NERC Rules of Procedure, to be elected a nominee must meet both of the following criteria:

- Receive the highest total number of votes in that Segment; and
- Receive a simple majority of the votes cast in that Segment.

If no candidate meets both criteria through the initial ballot, a second ballot will be conducted in that Segment. For the second ballot, the slate consists of the two candidates who received the highest number of votes in the initial ballot. The candidate receiving the highest number of votes in the second ballot is elected to represent that Segment. BOARD OF TRUSTEES AND FERC ACTION

NEW Opportunity to Suggest Canadian Candidates for NERC Board of Trustees

The Nominating Committee for the NERC Board of Trustees is providing an opportunity for stakeholders to suggest candidates to serve as an independent Canadian member of NERC's Board of Trustees.

A <u>summary memo</u> from Ken DeFontes, chair of the Nominating Committee, outlines the role of the committee and the process for the nomination and election of independent members of the NERC Board. The memo includes a position specification prepared by the committee and Odgers Berndtson Canada. The Nominating Committee has retained Odgers Berndtson to assist in the search for and screening of candidates. Please submit all suggestions for candidates to <u>Trevor Smith of Odgers Berndtson</u> by March 13, 2020.

NEW NERC Filings

On February 21, 2020, NERC submitted to FERC a motion for the extension of the compliance filing deadline in response to the January 23, 2020 Five-Year Performance Assessment <u>Order</u>.

Also on February 21, NERC submitted to FERC a <u>petition</u> requesting approval of seven proposed Reliability Standards developed under <u>Project</u> <u>2017-07 Standards Alignment with Registration</u>:

- FAC-002-3 Facility Interconnection Studies
- IRO-010-3 Reliability Coordinator Data Specification and Collection



- MOD-031-3 Demand and Energy Data
- MOD-033-2 Steady-State and Dynamic System Model Validation
- NUC-001-4 Nuclear Plant Interface Coordination
- PRC-006-4 Automatic Underfrequency Load Shedding
- TOP-003-4 Operational Reliability Data

The proposed standards seek to align the standards to changes previously approved by FERC following NERC's Risk-Based Registration Initiative and clarify other functional category language to promote unity across Reliability Standards.

NEW FERC Issuances

On February 18, 2020, FERC issued a <u>letter order</u> approving NERC and NPCC's <u>joint petition</u> for approval of regional Reliability Standard PRC-006-NPCC-2 – NPCC Automatic Underfrequency Load Shedding. FERC's 2020 issuances are available <u>here</u>.

NEW FERC Open Meeting Action

At its monthly open meeting, FERC took action on two key reliability items. FERC released a notice of inquiry (NOI) on virtualization and cloud computing services. Separately, FERC ordered NERC to submit an informational filing on the schedule and plans for open standard development projects on these two topics. The NOI focuses on the benefits and risks associated with virtualization and cloud computing for use in operating the Bulk Electric System (BES). It seeks comments on potential vulnerabilities of moving sensitive data to the cloud, methods to mitigate them and whether barriers to the use of these technologies exist in Critical Infrastructure Protection (CIP) Reliability.

The informational filing will include the schedule and plans for two NERC standard development projects, Project 2016-02 and Project 2019-02. NERC launched the standard development Project 2016-02 in response to Order No. 822. In addition to having addressed directives identified in Order No. 822, Project 2016-02 is now developing modifications to address stakeholder-identified issues, including clarifying the use of virtualization technologies. Project 2019-02, initiated based on stakeholder-identified issues, addresses BES Cyber System Information Access Management. The proposed modifications seek to enhance the CIP standards by providing a secure path toward the use of third-party data storage and analysis systems and by clarifying the protections expected when utilizing cloud services.
