**RE: Errata to Notice of Filing of the North American Electric Reliability Corporation  
of Proposed Reliability Standard PRC-005-2 (Protection System Maintenance)**

Dear Ms. Hamilton:

On March 11, 2013, the North American Electric Reliability Corporation (“NERC”) filed a Notice of Filing of proposed Reliability Standard PRC-005-2 (Protection System Maintenance)

NERC is currently developing Version 3 of the PRC-005 Reliability Standard in Project 2007-17.2 Protection System Maintenance and Testing - Phase 2 (Reclosing Relays). The Implementation Plan for proposed PRC-005-3 carries forward language from the Implementation Plan for proposed PRC-005-2 for continuity. The revised language in the Implementation Plan for PRC-005-2 reads as follows:

Standards PRC-005-1b, PRC-008-0, PRC-011-0, and PRC-017-0, which are being replaced by PRC-005-2, shall remain active throughout the phased implementation period of PRC-005-2 and shall be applicable to an entity’s Protection System component maintenance activities not yet transitioned to PRC-005-2. Standards PRC-005-1b, PRC-008-0, PRC-011-0, and PRC-017-0 shall be retired at midnight of the day immediately prior to the first day of the first calendar quarter one hundred fifty-six (156) months following applicable regulatory approval, or as otherwise made effective pursuant to the laws applicable to such ERO governmental authorities; or in those jurisdictions where no regulatory approval is required, at midnight of the day immediately prior to the first day of the first calendar quarter one hundred sixty-eight (168) months following NERC Board of Trustees adoption.

The quoted language is procedural in nature and was inadvertently omitted from the Implementation Plan. The Standards Committee approved the errata change and additional minor changes on October 17, 2013.<sup>1</sup> Accordingly, NERC requests consideration of the attached revised implementation plan for proposed PRC-005-2.
