**NOTICE OF FILING OF THE  
NORTH AMERICAN ELECTRIC RELIABILITY CORPORATION REGARDING  
PROPOSED AMENDMENTS TO THE ELECTRIC RELIABILITY ORGANIZATION’S  
RULES OF PROCEDURE**

On June 30, 2017, the North American Electric Reliability Corporation (“NERC”) submitted proposed revisions to Section 600 (Personnel Certification) and Section 900 (Training and Education) of the NERC Rules of Procedure (“ROP”).<sup>1</sup> On July 19, 2017, the Federal Energy Regulatory Commission (“FERC”) issued an order rejecting NERC’s proposed revisions to sections 603, 604, and 605 of the ROP and directed NERC to:

- (i) restore Rule of Procedure Sections 603 (Examination and Maintenance of NERC System Operator Certification Credentials), 604 (Dispute Resolution Process) and 605 (Disciplinary Action), and
- (ii) correct typographical errors in proposed Sections 600 and 900.

NERC submits this filing to restore those sections of the ROP and to correct the typographical errors.
