MOTION OF THE NORTH AMERICAN ELECTRIC RELIABILITY CORPORATION REQUESTING ISSUANCE OF PRELIMINARY ASSESSMENT IN RESPONSE TO THREE-YEAR ELECTRIC RELIABILITY ORGANIZATION PERFORMANCE ASSESSMENT REPORT

I. INTRODUCTION

On July 20, 2009, the North American Electric Reliability Corporation ("NERC") submitted its *Three-Year Electric Reliability Organization Performance Assessment Report* ("ERO Performance Report") in accordance with the Federal Energy Regulatory Commission's ("Commission" or "FERC") regulations. *See* 18 C.F.R. §39.3(c).

Pursuant to Rule 212 of the FERC Rules of Practice and Procedure, 18 C.F.R. § 385.212, NERC hereby requests that the Commission have its staff issue a preliminary assessment of the electric reliability organization ("ERO") Performance Report for comment. Given that the ERO Performance Report was filed nearly a year ago, NERC expects that Commission action on the ERO Performance Report may occur soon. The issuance of a preliminary assessment will provide the opportunity for interested parties to weigh in on the preliminary conclusions and recommendations. It may avoid the prospect of protracted rehearing proceedings and possible litigation over issues that might better be resolved with an opportunity for evaluation and discussion prior to final decisions being made. Importantly, it will afford all interested persons, including ERO governmental authorities, state regulators, interested federal agencies, the

industry, customers and other stakeholders, an opportunity to provide valuable input that will aid the Commission in developing a complete record, prior to issuing a determination on the performance of the ERO in meeting its obligations under Section 215 of the Federal Power Act ("FPA").

III. BACKGROUND AND MOTION

NERC was formed to serve as the ERO authorized by Section 215 of the FPA. NERC was certified as the ERO by the Commission's Order issued July 20, 2006, pursuant to Section 215(c) of the FPA. As noted above, the Commission's regulations, at 18 C.F.R. Part 39, require the ERO to submit an assessment of its performance three years from the date of certification.

On July 20, 2009, NERC submitted its ERO Performance Report in accordance with Section 39.3(c) of the Commission's ERO regulations. Section 39.3(c) also provides that the Commission will establish a proceeding to allow public comment:

After receipt of the assessment, the Commission will establish a proceeding with opportunity for public comment in which it will review the performance of the Electric Reliability Organization.

- (1) The Electric Reliability Organization's assessment of its performance shall include:
 - (i) An explanation of how the Electric Reliability Organization satisfies the requirements of §39.3(b);
 - (ii) Recommendations by Regional Entities, users, owners, and operators of the Bulk-Power System, and other interested parties for improvement of the Electric Reliability Organization's operations, activities, oversight and procedures, and the Electric Reliability Organization's response to such recommendations; and
 - (iii) The Electric Reliability Organization's evaluation of the effectiveness of each Regional Entity, recommendations by the Electric Reliability Organization, users, owners, and operators of the Bulk-Power System, and other interested parties for improvement of the Regional Entity's performance of delegated functions, and the Regional Entity's response to such evaluations and recommendations.³

NERC recognizes that the Commission has already received public comment on the ERO Performance Report. However, NERC has not received any feedback on the report from the Commission or its staff. By this motion, NERC requests that the Commission have its staff issue a preliminary assessment of the ERO Performance Report, and that it solicit comments from interested persons prior to taking final action in response to the ERO Performance Report.

NERC and all stakeholders would benefit from an open dialogue with the Commission about the status of implementation of Section 215 and how the Commission expects that to evolve. This

docket provides an appropriate vehicle for a general examination of the relationship between NERC and the Commission going forward. By allowing public comment on the preliminary assessment prior to final action, the parties can gain a common understanding of the issues or at least understand the differences related thereto. It will ensure that the Commission has a fully informed and developed record upon which to make a final decision. This also may obviate protracted rehearing proceedings and possible litigation.

NERC's motion is consistent with Commission precedent. On May 11, 2006, the Commission issued a Staff Preliminary Assessment of the NERC Reliability Standards. In the Staff Preliminary Assessment, the Commission noted:

This preliminary staff assessment is the first step in an open and inclusive process that will allow interested persons to submit comments on whether the proposed mandatory Reliability Standards found in NERC's petition meet the statutory criteria and will allow the Commission to develop an adequate record on which to make the required statutory findings.⁴

Approximately 50 entities filed comments in response to the Staff Preliminary Assessment.⁵

The Commission's review of the NERC Reliability Standards is analogous to its review of the ERO Performance Report. Thus, it is important that the industry and affected stakeholders have an opportunity to review a preliminary assessment prior to the Commission taking final action on the ERO Performance Report.
