The North American Electric Reliability Corporation ("NERC") hereby submits two privileged and confidential attachments also containing critical energy infrastructure information in response to the request made by the City of Holland ("Holland") in this proceeding on November 17, 2011. The attachments consist of the Michigan Electric Transmission Company, LLC ("METC") system restoration procedures/plan ("SRP"). Attachment A is the version of the SRP updated on February 1, 2008. Attachment B is what NERC understands to be the currently effective SRP.
