Introduction and Chair's Remarks

Policy Input Reminder

Mr. Marshall noted that the Board requests input on three specific topics: proposed 2019 ERO dashboard metrics and NERC corporate metrics, Reliability Issues Steering Committee Report on Resilience, and ERO Enterprise Program Alignment efforts. The background material for the metrics will be distributed in a supplemental letter and responses on that topic may be submitted through Tuesday, October 30. The Board is also requesting input on the preliminary agenda topics presented during the MRC Informational Session. There will be time dedicated on the MRC's November 6, 2018, agenda for MRC members to provide input and advice on the Board agenda items after the final package has been posted. NERC staff provided updates on the topics included in the policy input letter.
