2. MOD-001, MOD-008, MOD-028, MOD-029, and MOD-030 Standards Redraft and Review

Andy Rodriquez developed a preliminary schedule and shared it with the drafting team (see **Attachment 1**).

The drafting team reviewed the standards and comments. Minor changes were reviewed and made as appropriate. The drafting team split into sub-groups to work on each of the five standards.

The drafting team spent a significant amount of time working on the development of "Quality" measures for the ATC calculations. Most of the calculations were able to be addressed easily, but the ETC calculation had to have a special measure developed to ensure its quality.

Language related to Special Protection Schemes was added to MOD-030. Andy was tasked with brining this language to Gerry Adamski and Ed Dobrowski to ensure the ATC standards were not creating conflicts with other standards in development.

There was a brief discussion regarding the use of Internal ATC, as described in Order 638.

Andy Rodriquez was tasked with consolidating the comment form questions discussed and updating the implementation plans and comment responses.
