The various team members discussed the Rules of Procedure, several FERC Directives and Orders that provide guidance and direction. The team discussion covered several relevant perspectives. After much discussion the SDT members could not reach a strong consensus. The SDT does collectively have a better sense of the guidelines, considerations, and requirements of the interpretation process.
