#### **BACKGROUND:**

On November 19, 2003, the U.S.—Canada Power System Outage Task Force issued its Interim Report <a href="http://www.doe.gov/engine/content.do">http://www.doe.gov/engine/content.do</a> explaining the factual causes of the August 14 blackout in the northeast United States and Ontario, Canada. A final report, to be issued early in 2004, will present the conclusions of the investigation and recommendations aimed at preventing large-scale outages in the future. The Task Force is holding three open forums, in which the public will have an opportunity to comment on the Interim Report and present recommendations for consideration of the Task Force. ### NOTICE OF INDUSTRY TECHNICAL CONFERENCE ON AUGUST 14 BLACKOUT:

The electric systems investigation team supporting the Task Force will conduct a technical conference on December 16 (8 a.m. to 5:30 p.m.) at the Marriott Downtown Hotel in Philadelphia.

The conference is focused on receiving technical inputs from electric industry participants on how to prevent and minimize the impacts of possible future cascading blackouts. The technical conference will include five panels of experts offering their views on recommendations to prevent large-scale blackouts. Those attending the technical conference will be able to ask questions and comment during an open discussion period after each panel session.
